

ORDINANCE NO. 80-131

AN ORDINANCE PROVIDING FOR THE ESTABLISHMENT OF A MUNICIPAL DEPARTMENT OF THE FIRST CIRCUIT COURT FOR MANTUA, BOX ELDER COUNTY, STATE OF UTAH.

BE IT ORDAINED BY THE TOWN COUNCIL OF MANTUA TOWN, UTAH, AS FOLLOWS:

SECTION 1: The Town of Mantua hereby establishes a Municipal Department of the First Circuit Court of Box Elder County for the Town of Mantua, said Court to have jurisdiction within the corporate limits of the Town of Mantua, Utah, said Court to be known officially as the Municipal Department of the First Circuit Court for Mantua, Box Elder County, Utah.

SECTION 2: The Town Council of Mantua hereby elects to utilize the existing judicial services located in Brigham City, Utah, which is a primary Circuit Court location as established by the Circuit Court Act of the State of Utah.

SECTION 3: In the opinion of the Mayor and Town Council of the Town of Mantua, it is necessary for the peace, health and safety of the inhabitants of the Town of Mantua that this Ordinance become effective immediately upon posting. This Ordinance shall be deposited in the office of the Clerk of the Town of Mantua and posted in three public places within said Town and shall take effect immediately upon its first such posting.

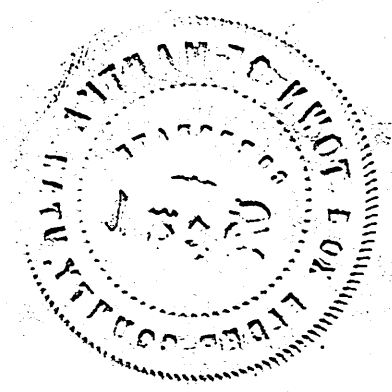
