

ORDINANCE NO. 107

AN ORDINANCE FIXING RATES FOR USE OF FIRE DEPARTMENT IN MANTUA TOWN.

BE IT ORDAINED BY THE TOWN BOARD OF MANTUA, UTAH, as follows:

Section 1. That whereas Mantua Town has, by contract, arranged with Brigham City Corporation for the furnishing of fire fighting service with Mantua Town and has agreed to pay Brigham City the sum of One Hundred Fifty Five (\$155.00) Dollars for the first hour or part thereof with additional sums to be paid for each additional hour or part thereof for said fire fighting service.

Section 2. It is hereby ordained that the occupant or owner of any dwelling or building where a fire originates within Mantua Town and as a consequence thereof the Brigham City Fire Department is called to extinguish said fire, shall be charged a fee of \$ 100.00 for the first hour or any portion thereof and \$ 50.00 for each succeeding hour or any portion thereof.

Section 3. That in the opinion of the Town Board of Mantua, Utah, it is necessary to the health, peace and safety of the inhabitants of said town that this ordinance shall take effect upon its passage and first posting and it is hereby ordered that this ordinance shall take effect upon its first passage and posting. This Ordinance shall be deposited in the office of the clerk of the Town of Mantua and posted in three public places within said town.

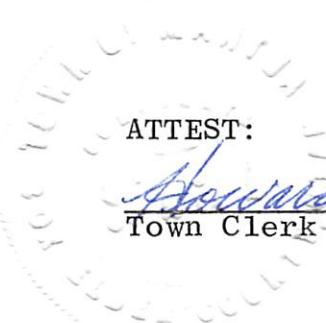

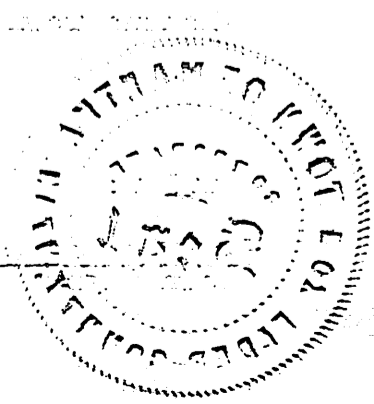

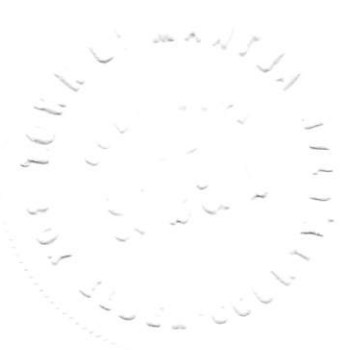
