

ORDINANCE NO. 80-129

AN ORDINANCE AMENDING ORDINANCE NO. 103 A  
ADOPTED FEBRUARY 17, 1972, AND PROVIDING  
FOR THE REGISTERING AND LICENSING OF DOGS

BE IT ORDAINED BY THE TOWN COUNCIL OF MANTUA AS FOLLOWS:

Section 1: Section 1 of Ordinance No. 103A adopted by the Town Council of Mantua Town, Utah on the seventeenth day of February, 1972, hereby amended to read, as follows:

Section 1: Dogs To Be Registered; Annual Tax.

It shall be unlawful for any person to own or keep a dog within the corporate limits of Mantua Town without making application to the Collector of dog tax for that purpose and to pay to said collector for the benefit of the Town, an annual tax of \$5.00 for a female dog and \$3.00 for a male dog or a female dog that has been spayed. The said license shall be due and payable beginning with the first day of January each year and shall be delinquent if not paid on or before the fifteenth day of March of each year, and shall expire on the the 31st day of December of each year in which said license is secured. Provided, that there shall be an additional license fee of \$5.00 charged for any license not issued prior to March 15 for any dog which was within the corporate limits of Mantua Town within said year and prior to the 15th day of March of the year in question. All dogs brought into Mantua Town after March 15 in any year shall be charged the original rate of license, if purchased within ten days from the date of arrival. Thereafter the license fee shall increase \$5.00.

Section 2: In the opinion of the Mayor and Town Council of the Town of Mantua, it is necessary for the peace, health and safety of the inhabitants of the Town of Mantua that this ordinance become effective immediately upon posting. This Ordinance shall be deposited in the office of the Clerk of the Town of Mantua and posted in three public places within said Town and shall take effect immediately upon its first such posting.

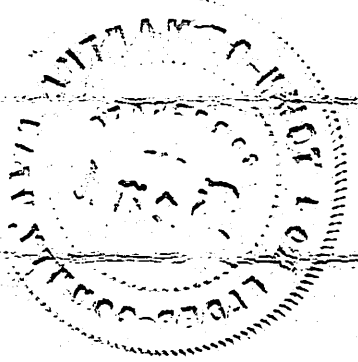
