

## **ORDINANCE NO. 2015-10-15A**

WHEREAS, the Town Council of Mantua Town, Box Elder County, Utah having previously adopted ORDINANCES OF MANTUA TOWN; and,

WHEREAS, the Town Council has determined that for the general safety and welfare of the residents of Mantua there is a need to establish an ordinance concerning parking on streets in the Town of Mantua during the winter season.

NOW, THEREFORE, the Town Council of Mantua, Utah, hereby adopts, passes and establishes the following:

### **AN ORDINANCE REGULATING AND CONTROLLING THE PARKING OF VEHICLES ON STREETS DURING THE WINTER SEASON WITHIN THE TOWN OF MANTUA.**

NOW, THEREFORE, BE IT ORDAINED by the Town Council of Mantua, Box Elder County, State of Utah as follows:

1. **Night Parking.** It is unlawful for the driver or owner of any vehicle to park any vehicle or equipment on any street or right of way in the Town of Mantua between November 1 of each year and April 1 of the following year, between the hours of twelve o'clock (12:00) midnight and six o'clock (6:00) a.m. the next day, for a period of time longer than three (3) minutes when loading or unloading passengers. This subsection shall not apply to doctors on house calls, emergency vehicles, or vehicles used in the repair of utilities.

2. **Hour Limitation.** No person who owns or has possession, custody or control of any trailer or vehicle shall park or leave standing in such vehicle on any public road, street, alley or Town property in the Town of Mantua for forty-eight (48) or more consecutive hours, and any vehicle so parked or left standing may be impounded and removed by the police. For purposes of impoundment removal, the police may impound and remove any vehicle which reasonable appears to have remained unmoved for forty-eight (48) consecutive hours. The cost of impoundment and removal shall be charged to the owner or any person who claims the impounded vehicle. These restrictions are only effective during the same time limitations stated in subsection 1 of this Ordinance.

3. **Penalties.** In addition to the penalties set forth above, any person who violates this Ordinance shall be guilty of an infraction and shall pay a fine in the following amounts:

First offense: \$25.00

Second offense: \$50.00


Third offense: \$50.00

Any further offenses: \$50.00 subject to being towed


THIS ORDINANCE shall become effective upon posting as required by law.

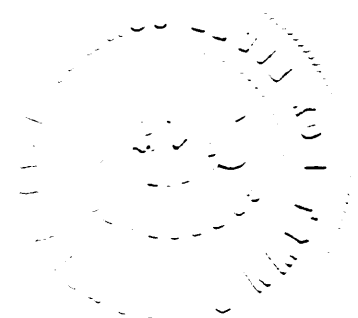

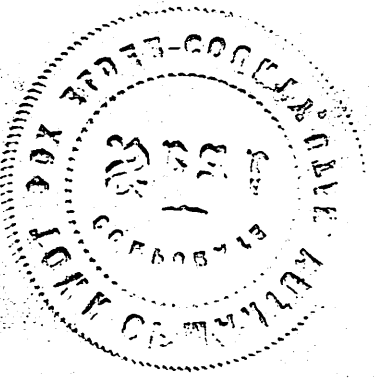
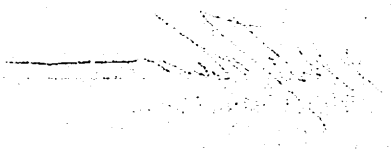
