

ORDINANCE NO. 2004-06-03

WHEREAS, the Town Council of Mantua Town, Box Elder County, Utah, having previously adopted ORDINANCES OF MANTUA CITY; and,

WHEREAS, the Town of Mantua has law enforcement jurisdiction and responsibility in areas in and around the Mantua Reservoir; and

WHEREAS, the Town Council has determined that for the general health and welfare of the residents of Mantua there is a need to establish an ordinance concerning camping within the Town of Mantua.

NOW, THEREFORE, the Town Council of Mantua, Utah, hereby adopts, passes and establishes the following:

AN ORDINANCE PROHIBITING CAMPING IN THE MANTUA TOWN LIMITS ON PUBLIC PROPERTY EXCEPT IN DESIGNATED AREAS; PROVIDING PENALTIES FOR THE VIOLATION HEREOF AND REPEALING ALL ORDINANCES IN CONFLICT HEREWITH.

WHEREAS, Mantua Town is a Utah Municipal Corporation lawfully organized and existing under the laws of the State of Utah; and

WHEREAS, the Mantua Town Council finds it to be in the best interests of the Town of Mantua and its residents that a new Ordinance be created prohibiting camping in the Mantua Town limits on public property, except in designated areas, and that the new Ordinance governing the subject matter be enacted.

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE TOWN OF MANTUA:

Section 1. Overnight camping within the Mantua Town limits on public property is hereby prohibited, except in areas specifically designated and marked by visible signage as an overnight camping area.

Section 2. Violation of this ordinance shall be punishable as a Class C Misdemeanor or as an Infraction, in the discretion of the Town's law enforcement personnel and its prosecuting attorney.

Section 3. Any ordinances or parts of ordinances that are in conflict herewith are herewith and hereby repealed.

Section 4. This Ordinance shall become effective upon posting as required by law.
