

**AMENDMENT TO ORDINANCE 04-08-05**

**OBEYING REGULATORY SIGNS**

**ORDINANCE # 2016- 08-18(D)**

WHEREAS, the State of Utah has determined that most violations of the traffic code should be punishable as infractions rather than misdemeanors.

WHEREAS, the Town Council of Mantua has concluded that those ordinances similar in nature, but not necessarily related to the Utah State traffic code should reflect the spirit of those changes to the severity of punishments.

NOW THEREFORE, The Town Council of Mantua, Utah, hereby adopts, passes and establishes the following:


AN AMMENDMENT TO ORDINANCE 04-08-05, SECTION 3, WHICH SHALL READ, Violation of this ordinance shall be punishable as an Infraction with a fine of \$75.00.

ORDINANCE NO. 604-08-05

WHEREAS, the Town Council of Mantua Town, Box Elder County, Utah, having previously adopted the ORDINANCES OF THE TOWN OF MANTUA; and,

WHEREAS, the Town of Mantua has law enforcement jurisdiction and responsibility in off-road areas, as well as on the Mantua Reservoir; and

WHEREAS, Utah Code Annotated Section 41-6-23 (the "State Statute") requires that operators of vehicles must obey the instructions of any official traffic-control device in the State of Utah, including within the Town limits of the Town of Mantua; and

WHEREAS, the Town Council has determined that for the general health and welfare of the residents of the Town of Mantua, there is a need to establish an ordinance requiring all persons, not just the operators of vehicles, to obey regulatory signs and devices within the town limits of the Town of Mantua.

NOW, THEREFORE, the Town Council of Mantua, Utah, hereby adopts, passes and establishes the following:

**AN ORDINANCE REQUIRING ALL PERSONS IN THE TOWN OF MANTUA TO OBEY REGULATORY SIGNS AND DEVICES; PROVIDING PENALTIES FOR THE VIOLATION HEREOF AND REPEALING ALL ORDINANCES IN CONFLICT HEREWITH.**

**WHEREAS**, the State Statute requires that operators of vehicles must obey the instructions of any official traffic-control device in the State of Utah; and

**WHEREAS**, the Mantua Town Council finds it to be in the best interests of the Town of Mantua and its residents that an Ordinance be enacted that requires all persons, not just the operators of vehicles, to obey regulatory signs and devices within the town limits of the Town of Mantua.

**NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE TOWN OF MANTUA:**

Section 1. All persons shall be required to obey any official regulatory sign or device within the town limits of Mantua Town. Examples of such regulatory signs or devices include, but are not limited to, the following:

- A. No Fishing From Boat Dock;

- B. No Parking in Posted Areas;
- C. No Trespassing in Posted Areas;
- D. No Activities in Posted Areas;
- E. No Unauthorized Personnel in Designated Areas; and
- F. Other similar regulatory signs and devices.

Section 2. Compliance with this Ordinance shall be required upon the placement of any regulatory sign or device authorized by any legislative body having jurisdiction. Failure to notice or observe a clearly posted regulatory sign or device shall not be a defense to a violation hereunder.

Section 3. Violation of this Ordinance shall be punishable as a Class C Misdemeanor.

Section 4. Any violation of the State Statute within the Town of Mantua shall be subject to the fines, penalties, or other sanctions established by the State Statute. Any violation of this Ordinance within the Town of Mantua that is not also a violation of the State Statute shall be subject to the fines, penalties, or other sanctions established by the Mantua Justice Court.


Section 5. Any ordinances or parts of ordinances that are in conflict herewith are herewith and hereby repealed.


THIS ORDINANCE shall become effective upon posting as required by law.
