

Ordinance number 2017-03-02(E)

AN ORDINANCE PROVIDING FOR THE COMPENSATION OF ELECTED AND STATUTORY OFFICERS OF THE TOWN OF MANTUA

WHEREAS, the number of duties assigned to each elective officer has increased significantly and each elected officer is required to devote more time to the effective administration of this municipality, and

WHEREAS, public service obligates elected officers to spend their own money in the service of the municipality, and

WHEREAS, elected officer should be fairly compensated for their time and expenses,

THEREFORE, be it ordained by the Town Council of the Town of Mantua that:

1. Repealer. All previous salary or compensation ordinances regarding elected and statutory officers hereby are repealed.
2. Compensation. The yearly compensation of the elected officer shall be as follows;
Mayor \$100.00
Councilmember \$80.00
3. Payment. The treasurer shall pay each elected and statutory officer on the last regular business meeting of the last month of the year by delivery of a check drawn on the municipal checking account to the elected officer personally or by mailing the check to the elected officer at his home, postage prepaid.
4. Per diem. Each member of the governing body shall receive mileage and per diem for all trips approved by the governing body, according to the schedule adopted by the Utah Department of Finance.
5. Effective date. This ordinance shall become effective on the 30th day after final passage or the 20th day after publication or posting, whichever occurs last.

ORDINANCE NO 78-126

AN ORDINANCE PROVIDING FOR THE COMPENSATION OF ELECTED AND STATUTORY OFFICERS OF TOWN OF MANTUA.

Mayor	\$	<u>60.00</u>
Council member	\$	<u>40.00</u>
Attorney	\$	<u>250.00</u>

3. Payment. The treasurer shall pay each elected and statutory officer on the last regular business meeting of the last month of the year by delivery of a check drawn on the municipal checking account of the elected officer personally or by mailing the check to the elected officer at his home, postage prepaid.

4. Per Diem. Each member of the governing body shall receive mileage and per diem for all trips approved by the governing body, according to the schedules adopted by the Utah Department of Finance.

5. Effective Date. This ordinance shall become effective on the 30th day after final passage or the 20th day after publication or posting, whichever occurs last.
