

AN ORDINANCE

An Ordinance Supplementing Existing Traffic Ordinances  
Of Mantua Town, Utah

BE IT ORDAINED BY THE TOWN BOARD OF MANTUA TOWN, UTAH:

SEC. 1. All past ordinances and parts of ordinances which conflict with this ordinance are hereby repealed. All non-conflicting past traffic ordinances and parts of ordinances not already repealed are hereby made a part of this ordinance.

SEC. 2. Within the limits of Mantua Town, Box Elder County, State of Utah, the speed through school zone shall not exceed 15 miles per hour; the speed through the main street shall not exceed 25 miles per hour; and the speed in the residence district shall not exceed 35 miles per hour.

SEC. 3. It shall be unlawful to drive through stop signs without first coming to a complete stop.

SEC. 4. PENALTY: Any person violating this ordinance or any part of it shall be guilty of a misdemeanor and is liable to punishment by a fine not exceeding \$49.00 or by imprisonment not exceeding 30 days, or both such fine and imprisonment.

This ordinance shall take effect upon its passage, approval and posting.

not exceeding 30 days, or both such fine and imprisonment.

ed and posting.
