AGREFMENT PROVIDING POLICE SERVICES BY THE BOX ELDER COUNTY SHERIFF'S OFFICE TO MANTUA TOWN, A MUNICIPAL CORPORATION:

This agreement made and entered into pursuant to Section 11-13-1 of the Utah Code Annotated, 1953, as amended, commonly referred to as the Interlocal Cooperation Act, by and between Box Elder County, a municipal corporation of the State of Utah, hereinafter referred to as County, and Mantua Town, a municipal corporation of the State of Utah, hereinafter reffered to as Town.

The Town desires to enter into this contract with the County for the Box Elder County Sheriff's Office to provide police services for the incorporated area of Mantua Town.

The Town Council and the Board of Commissioners have decided and been determined that police services and protection are needed within the incorporated area of Mantua Town, and is believed by both parties that it will be mutually advantageous to each party to enter into this agreement.

It is anticipated that the services provided would be compensated by the Town on a cost basis as set forth, and the respective parties have determined and agreed that the set amount is a resonable, fair, and adequate compensation for the police services.

Therefore, in compliance with and pursuant to the terms and provisions of the Interlocal Cooperation Act as hereinabove set forth, the County and the Town do hereby contract and agree with each other as follows:

- 1.) The Box Elder County Sheriff's Office agrees to furnish all reasonable police protection for a peroid of one year, commencing June 15, 1978 through June 15, 1979 and on a yearly basis thereafter, with police protection for the purpose of enforcing the State laws, County and Town ordinances within the incorporated limits of Mantua Town.
- 2.) The Sheriff's Office agrees to provide the following property and services to Mantua Town, which property shall remain the sole property of the Box Elder County Sheriff's Office, and is understood and agreed that no part of the property will be that of Mantua Town upon termination of this agreement, and that all property used by the Sheriff's Office in this agreement shall be returned and retained by Box Elder County, which property consists of:
 - A. Answer any and all calls from the residents of Mantua Town for police services, with the exception of dog complaints and junk vehicle complaints in which case the citizens will be reffered by the County dispatcher to the appropriate agency to handle such complaint.
 - B. Stepped up patrols and security checks of said Town for traffic offenses, and for the safty and welfare of the residents of Mantua Town.

- C. 24 radar patrols per year for the purpose of speed control within the incorporated limits of Mantua Town.
- 3.) The personnel and equipment shall represent an actual active field force at all times, 24 hours a day, 7 days a week, law enforcement that can be sent upon request as deemed appropriate to answer any calls for protection from the Mantua Town residents, subject to personnel restrictions of said Sheriff's Office.
- 4.) Police services in the incorporated limits of Mantua Town shall be rendered under the direction of the Box Elder County Sheriff.
- 5.) The Sheriff's personnel provided under this agreement shall be appointed by the Box Elder County Sheriff's Office under its normal rules of selection and hiring of such personnel.
- 6.) All salaries, cost of equipment, vehicles, and other direct expenses incurred by entering into this contract shall be paid by the Box Elder County Sheriff's Office and reimbursed by Mantua Town as specified in item # 8.
- 7.) It is agreed the Box Elder County Sheriff's Office will furnish all reasonable police protection and services to enforce all State laws, (Federal Statutes as far as the same is applicable), which comes within the knowledge and notice of the members of the Sheriff's Office.
- 8.) Mantua Town agrees that it will pay the sum of \$800.00 to the Box Elder County Treasure on or before the 15th day of June, 1978, for the services agreed upon.
- 9.) It is hereby agreed and understood that the responsibility for administrating this contract shall consist of a joint board, consisting of the Town President of Mantua, the Chairman of the Box Elder County Commission, and the Sheriff of Box Elder County, who shall set the policies for the administration of the police services, and that at no time will any property be purchased with funds of Mantua Town pursuant to law enforcement responsibility, and upon termination of this contract, all property will remain the sole property of Box Elder County.
- 10.) It is agreed that this contract may be terminated by either party by giving 30 days written notice of their desires to terminate the same for the next ensuing annual term, in which event the same contract will terminate on the following ______.
