ORDINANCE NO. 90-10-5

WHEREAS, the City Council of Mantua, Utah, passed and posted an Ordinance adopting a Code titled THE CODE OF REVISED ORDINANCES OF MANTUA CITY on Sept 20,1990; and

WHEREAS, in Chapter /3-/// of Title $/3-\mathcal{OOO}$ at Part /A provisions were adopted regulating the streets and providing for traffic control within the municipality;

WHEREAS, the City Council has determined there is a need to update and amend these regulations in order to more adequately protect the best interests and welfare of the residents of the municipality;

NOW, THEREFORE, THE CITY COUNCIL OF MANTUA CITY, UTAH, HEREBY ADOPTS, PASSES AND PUBLISHES THE FOLLOWING:

AN ORDINANCE ADOPTING A UNIFIED TRAFFIC CODE.

BE IT ORDAINED BY THE CITY COUNCIL OF MANTUA CITY, BOX ELDER COUNTY, STATE OF UTAH, AS FOLLOWS:

1. The following is adopted as the Uniform Traffic Code of Mantua City:

ADOPTION OF UNIFORM TRAFFIC CODE. The State of Utah Traffic Rules and Regulations, 1990 Edition, and subsequent editions, as compiled, prepared and published as a code in book form by the Utah Department of Public Safety and as they may be subsequently amended by legislative act or executive order, three (3) copies of which have been filed for use and examination by the public in the office of the municipal recorder/clerk, hereby are approved and adopted as the traffic code for this municipality except as such code may be altered or modified by the ordinances of this municipality. Three (3) copies of any subsequent editions shall be filed for use and examination by the public in the office of the municipal recorder/clerk upon receipt by the city.

2. The penalties for violations of the Uniform Traffic Code shall be as follows:

PENALTIES. Any person violating, causing or permitting violation of any provision of this part shall be guilty of a misdemeanor. Notwithstanding other language or provisions in the State of Utah Traffic Rules

and Regulations, 1990 Edition, and subsequent editions, hereby adopted, any violator of this part, upon conviction, shall be punished by a fine of not more than \$1,000.00, or by a jail sentence not to exceed six (6) months, or by both a fine and jail sentence, provided that minimum sentences and all other sanctions consistent with the aforementioned guidelines and contained in said 1992 Code Edition, and subsequent editions, are incorporated here in this Section by reference.

- 3. Should any section, clause, or provision of this Ordinance, or the Traffic Code adopted hereby, be declared by a court of competent jurisdiction to be invalid, in whole or in part, the sale shall not affect the validity of the Ordinance or the Code as a whole, or any other part thereof.
- 4. The existing Traffic Code of Mantua City, Utah, is hereby superseded and amended to read as set forth herein. All previous ordinances inconsistent with this ordinance and the rules and regulations herewith adopted are hereby repealed.
- 5. This Ordinance shall become effective immediately upon the posting of three (3) copies at three (3) public places within the corporate limits of Mantua City.
