NOW THEREFORE, the City Council of Mantua City, Utah, hereby adopts, passes and publishes the following:

AN ORDINANCE RESTRICTING THE DISCHARGE OF FIREARMS WITHIN THE MANTUA CITY LIMITS.

BE IT ORDAINED BY THE CITY COUNCIL OF MANTUA CITY, BOX ELDER COUNTY, STATE OF UTAH AS FOLLOWS: .

- Restrictions on the Discharge of Firearms.
- (A) It shall be unlawful for any person to discharge any firearm within the city limits except as follows:
 - (1) At any location, unless otherwise prohibited, when given prior specific approval by the Mantua Police Chief.
 - (2) In lawful defense of property, person or self.
 - (3) In the case of any peace officer in the discharge of his duty.
 - (4) During hunting season, if the person discharging the firearm is lawfully hunting with a shotgun and not a rifle and possesses a current and valid small game license, and provided the firearm is not discharged any closer than 500 feet from the nearest building.
- (B) A violation of this section shall be a Class B Misdemeanor.
- 2. This Ordinance shall become effective immediately upon the posting of three (3) copies at three (3) public places within the corporate limits of Mantua City.
